2021 Senate Legislative Session

LIFE

1. CAP Action-SUPPORTED: Website; Adoption Information; Task Force (SB 1254)

Forms a task force to promote and highlight adoption as a loving option on the Arizona Department of Health Services website. Passed Senate 16-12-2. Passed House 31-28-1. Signed into law by Gov. Ducey on April 23, 2021.

2. CAP Action-SUPPORTED: Abortion; Unborn Child; Genetic Abnormality (SB 1457)

States pro-life policy for Arizona, prohibits abortion based on genetic abnormalities, ensures the abortion pill cannot be sent through the mail. Passed Senate 16-14. Passed House 31-29. Signed into law by Gov. Ducey on April 27, 2021.

3. CAP Action-SUPPORTED: Abortion Data; Survivors Act; Supporting (SCR 1009)

Calls on the United States Congress to enact the Born-Alive Abortion Survivors Protection Act and the Ensuring Accurate and Complete Abortion Data Reporting Act of 2019. Passed Senate 16-14. Passed House 31-29.

MARRIAGE AND FAMILY

4. CAP Action-SUPPORTED: Arizona Empowerment Scholarships Accounts (ESAs); Revisions (SB 1452)

Adds low-income students to those eligible for Empowerment Scholarship Accounts. Passed Senate 16-14. Failed in House.

5. CAP Action-SUPPORTED: Sex Education Instruction; Parental Rights (HB 2035)

Prohibits sex education prior to 5th grade and requires schools to provide sex education curricula for grades 5-12 for parents' review both online and in person. Passed Senate 16-13-1. Passed House 31-24-5. Signed into law by Gov. Ducey on July 9, 2021.

6. CAP Action-SUPPORTED: Abortion; Gestational Age; Limit (SB 1164)

Limits abortions after 15 weeks of gestation. Passed Senate 16-13-1. Passed House 31-26-3. Signed into law by Gov. Ducey on March 30, 2022.

7. CAP Action-SUPPORTED: Organ Transplants; Disabilities; Discrimination; Prohibition (HB 2659)

Prohibits covered entities from denying an organ transplant or related service based solely on the fact that the individual has a disability. Passed Senate 27-0-3. Passed House 59-0-1. Signed into law by Gov. Ducey on April 25, 2022.

MARRIAGE AND FAMILY

8. CAP Action-SUPPORTED: Strike Everything; Minor Gender Transition Procedures (SB 1138)

Ensures that healthcare providers can not perform "gender transition" surgeries on minors. Passed Senate 16-12-2. Passed House 31-26-3. Signed into law by Gov. Ducey on March 30, 2022.

- 9. CAP Action-SUPPORTED: Interscholastic; Intramural Athletics; Biological Sex (SB 1165)
- Prohibits biological boys and men from playing on girls' and women's scholastic sports teams. Passed Senate 16-13-1. Passed House 31-24-5. Signed into law by Gov. Ducey on March 30, 2022.
- 10. CAP Action-SUPPORTED: Schools; Materials; Activities; Posting; Review (SB 1211)

Ensures parents have access to review instructional materials and activities used in their child's school, including textbooks, reading materials, websites, videos, and online applications used for student instruction. Passed Senate 16-13-1. Failed House 28-30-2.

11. CAP Action-SUPPORTED: Parental Rights; Schools; Educational Records (HB 2161)

Clarifies existing parental rights laws that a parent has access to a minor child's medical and educational records, requires parental notification and consent for student surveys. Allows parents to sue for violations of their rights. Passed Senate 16-12-2. Passed House 31-26-3. Signed into law by Gov. Ducey on April 29, 2022.

12. CAP Action-SUPPORTED: School Tuition Organizations; Revisions; Credit (HB 2278)

Increases the contributions cap on the individual Credit for Contributions to STOs and the aggregate cap on the Corporate Tax Credit for Contributions to STOs for Displaced or Disabled Students. Failed Senate 15-11-4.

13. CAP Action-SUPPORTED: Arizona Empowerment Scholarship Accounts (ESAs); Appropriation (HB 2853)

Extends eligibilty for ESAs to all Arizona school children. Passed Senate 16-10-4. Passed House 31-26-3. Signed into law by Gov. Ducey on July 7, 2022.

RELIGIOUS FREEDOM

14. CAP Action-SUPPORTED: Adoption; Religious Discrimination; Prohibition (SB 1399)

Prohibits discrimination against faith-based agencies in adoption and foster care placement. Passed Senate 16-11-3. Passed House 31-26-3. Signed into law by Gov. Ducey on April 6, 2022.

15. CAP Action-SUPPORTED: Care facilities; Clergy Visitation (HB 2449)

Allows clergy visits to residential health care facilities when the facility allows any other kind of in-person visitation. Passed Senate 18-10-2. Passed House 57-2-1. Signed into law by Gov. Ducey on April 25, 2022.

16. CAP Action-SUPPORTED: Religious Services; Essential Services (HB 2507)

Ensures that churches and other religious organizations receive equal treatment during a public crisis, allowing them to remain open on the same terms as other businesses and services that are deemed essential. Passed Senate 16-12-2. Passed House 35-22-3. Signed into law by Gov. Ducey on April 25, 2022.
